Motion by Paula B. second by Dick Stewart to change wording to say-- WSCA will approve score keeping service for the club hosting the state shoot-- vs. the WSCA hiring them on a contract—Motion carried

Motion by Pete M. second by Joe S. to approve remainder of state shoot criteria—Motion carried, one opposed Diane R.
